Category II	Leakage checking of the equipment containing fluorinated greenhouse gases in quantities of 5 tonnes of CO ₂ equivalent or more and not contained in foams, unless such equipment is hermetically sealed, is labelled as such and contains fluorinated greenhouse gases in quantities of less than 10 tonnes of CO ₂ equivalent, provided that it does not entail breaking into the refrigeration circuit containing fluorinated greenhouse gases; Installation, repair, maintenance, servicing and decommissioning of equipment containing less than 3 kilograms of fluorinated greenhouse gases, or, if hermetically sealed systems which are labelled as such are concerned, containing less than 6 kilograms of fluorinated greenhouse gases; and, Recovery of fluorinated greenhouse gases from equipment. Category III	Recovery of fluorinated greenhouse gases from equipment containing less than 3 kilograms of fluorinated greenhouse gases, or, if hermetically sealed systems which are labelled as such are concerned, containing less than 6 kilograms of fluorinated greenhouse gases.	N/A
Category IV	Leakage checking of the equipment containing fluorinated greenhouse gases in quantities of 5 tonnes of CO ₂ equivalent or more and not contained in foams, unless such equipment is hermetically sealed, is labelled as such and contains fluorinated greenhouse gases in quantities of less than 10 tonnes of CO ₂ equivalent, provided that it does not entail breaking into the refrigeration circuit containing fluorinated greenhouse gases.
